



Equipment Hire Terms and Conditions

Final Payment & Proof of Identity

The full amount for the hire period must be paid prior to the equipment be taken. We will accept credit card payment via Paypal, Bank cheque, Cash, or EFT (electronic transfer), ask Life's An Adventure for bank details. The Hirer must provide proof of ID, i.e Drivers License with photo and full address.

Bookings & Deposit

Life's An Adventure will temporarily book over the phone or email and hold that booking for a period of 48hrs or as agreed. To confirm booking a deposit of \$30 must be paid within the 48hrs or time agreed and Life's An Adventure will provide the customer (hirer) with a receipt by email as soon as possible.

Refund of Deposit

Full refund returned to customer (hirer) if hirer advises Life's An Adventure of cancellation of hire within 3 hours of booking.

Security Bond

The Hirer must supply a valid credit card details, so the value of \$500 can be deducted if required under the terms of this agreement. If a valid card details can not be provided a \$500 cash bond must be provided on collection of the equipment. The security bond will be used to covers damage or failure to return goods. If only minor damage has accrued, the amount payable by the hirer to Life's An Adventure is a reasonable cost to repair the damage. In the case of missing equipment, the value of the missing equipment will be payable to Life's An Adventure. The bond will be refunded the day the equipment has been returned less the cost of any missing equipment or damage.

Hire Period

All equipment is booked on either a daily basis. The hirer will be charged for all equipment hired at a "time taken" period and not a "time used" basis. Hire of our equipment is for the agreed time only, while every effort will be made to accommodate extensions to the initial hie period, we cannot guarantee that an extenuation of the hire will be available.

Late Returns

A late fee will apply if equipment is not returned on time. If returned late the hirer will be charged a daily rate. If the late return causes the cancellation of another booking the hirer may be charged a \$200 penalty

Cleaning

The hirer agrees that before hire, all equipment is cleaned and maintained (in good working order and condition) and should be returned in the same condition.



When returned the equipment must be clean, in good working order and condition, with all accessories. Equipment must be returned clean, dry and correctly packed, as you would expect to get it. If on return of the equipment it has not been cleaned a \$50 cleaning fee may be charged using the security bond.

- Backpacks. Hang to dry & air, clean out pockets and behind padding. Do not stuff items between base and base protector.
- Sleeping bags should be aired (hung out in the sun opened) before return.
- Sleeping bag liners must be washed and dried before return.
- Rollmatts. Rolled up tight with strap.
- Tents must be cleaned out and dried before return. Zips closed with poles & pegs rolled in for protection.
- Tent pegs: must be clean, dry and straight.

Marks on the tent canvas are to be cleaned with cloth and water only. (strictly no cleaning chemicals to be used as they damage the waterproof qualities of the canvas)

Damage or Theft

The hirer understands and agrees that, Life's An Adventure and any of its known affiliates are not accountable for any costs incurred to the hirer as a result of damage to or theft of any of our equipment during the period of hire.

Indemnity

The hirer agrees to use, operate and possess the equipment at the Hirer's risk. The hirer agrees that Life's An Adventure will have no responsibility or liability for any losses or damage to the property of the hirer. To the full extent permitted by the law the hirer releases, discharges and indemnifies Life's An Adventure from all claims and demands on Life's An Adventure arising out of or consequent on the use or misuse of the goods during the hire period.
